


## **HARDWARE KIT (Part # 91-067)**

- (6) Screw 10-32 x 5/8
- (1) Hex Wrench

## **TS1640/TS1022 ASSEMBLY**


- Adjust the telescoping section of the track stand to the approximate height of the AXS base, and secure with the locking pins.
- Place the front of the service track (TRACK50/TRACK25/TRACK31) on the cabinet opening and the rear on the service stand saddle. Ensure that the TRACK is level.
- 3) Bolt the service track to the AXS rough-in-pan using 10-32 hex cap screws and ball driver.
- 4) Level the service stand and lock it into place using the adjustment lever.





### **TS310 ASSEMBLY**

- 1) Adjust the saddle section of the track stand to the approximate height of the AXS base, and secure with the locking pins.
- 2) Place the front of the service track (TRACK50/TRACK25/TRACK31) on the cabinet opening and the rear on the service stand saddle. Ensure that the TRACK is level.
- 3) Bolt the service track to the AXS rough-in-pan using 10-32 hex cap screws and ball driver.
- 4) Level the service stand by adjusting the leveling feet with the 3/16 hex key provided.
