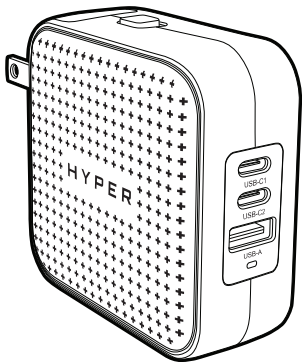

Introduction

The HyperJuice 70W USB-C GaN Travel Charger features 1 x USB-A and 2 x USB-C ports, enabling the simultaneous charging of multiple devices - laptops, tablets, smartphones, etc. This GaN wall charger is also capable of PD 3.0 charging speeds through either of the top two USB-C ports, allowing the fast charge of a MacBook Pro or other devices, up to 70W.

Four global travel adapters and a C8 adapter (supporting the charging of your devices through a C8 AC power cord.*) are all included with this charger.

*A C8 power cord is not included.

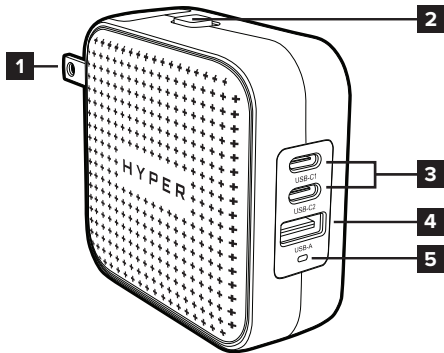

5. LED Power Indicator	Light indicates the charger is on and ready for use

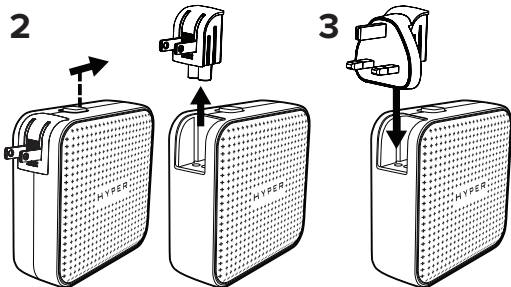
Operation Instructions

2. When changing the interchangeable AC plug (US AC plug as an example to illustrate the procedures), slide top lever forward first and remove it.

3. Slide in the appropriate interchangeable AC plug for the country you are in.


